Rules and Regulations

- 1. Zero Tolerance** for drug or alcohol use. No engaging in illegal substance manufacturing, possession and/or distribution will not be tolerated.
- 2. Zero Tolerance** for stealing. Taking food from others without permission is considered stealing. We encourage community-cooking, meal planning, and sharing dinnertime together. This is to assist in a family like structure.
- 3. Zero Tolerance** for destruction of Grace Recovery Homes for Woman houses or other residents' property.
- 4. Zero Tolerance** for sexual activity between residents.
- 5. Zero Tolerance** for physical confrontation or verbal confrontation with any staff or resident. **Absolutely NO** disrespect tolerated toward any member of management at any time.
- 6.** Any resident who is prescribed medications must immediately inform the house manager. All medication must be approved and taken as prescribed.
- 7.** As a member of a recovering community, based on the principles of honesty, trust and helping to create a safe sober environment. we request any resident who knows that another resident has violated any rules of Grace Recovery Homes report the behavior to staff.
- 8.** Any visitor of Grace Recovery Homes will be asked to leave immediately if staff or residents suspect any illegal or illicit drugs, including alcohol. Residents who have been asked to leave due to their own breach of rules will not be permitted back on the property.
- 9.** All residents must attend **90 AA/NA meetings their first 90 days** of residing at Grace Recovery Homes and then four meetings per week thereafter. Meeting verification sheets will be requested if deemed necessary.
- 10.** Residents must **obtain and maintain a good relationship with a sponsor** while living at Grace Recovery Homes.
- 11.** Residents must attend a mandatory House Meeting one time per week, every Sunday at 5 p.m.
- 12.** Residents are subject to random drug/alcohol screenings upon the request of any member of management.
- 13.** We request that a resident commit to 90-day stay, longer commitments will be discussed after 90 days.
- 14.** Residents' rooms must be clean at all times. (Residents' beds are to be made before they leave for the day)
- 15.** Curfew is 11:00 p.m. Sunday thru Thursday and 12:00 a.m. Friday and Saturday. If you are in your first 30 days, curfew is 10:00 p.m. 7 days a week.
- 16.** Residents must sleep at the house each night unless prior arrangements have been made with the staff.
- 17.** Overnight passes are given on a case-by-case basis, by staff, after 30 days of living at Grace Recovery Homes for Women. You must be in good standing and rent must be current.
- 18.** Residents must be employed or enrolled in school within the first 5 days of living at Grace Recovery Homes.

- 19. Residents having unusual job requirements must have Grace Recovery staff approval.
- 20. Residents not employed, or in school must attend the 7:30 AM NA meeting at the Church of the Redeemer Monday thru Friday.
- 21. Residents will participate in ongoing mandatory house chores, failure to complete chores will result in disciplinary action.
- 22. New residents are on a probationary period for their first 30 days meaning that they can only leave the house with trusted housemates, approved by management, unless otherwise specified.
- 23. Residents in first 30 days are on opposite sex **Ban**, meaning that there is to be no contact with the opposite sex unless previously discussed with a house manager. This will be extended past 30 days if not followed.

Please note violation of any one of these rules is means to terminate residency at any time at any of the Grace Recovery Homes for locations. Grace Recovery Homes reserve the right to terminate housing to its guest with or without cause based on transient guest laws.
